Freedom of Information Request

We are writing in response to your Freedom of Information request. Your request has been considered in accordance with the requirements of the Freedom of Information Act (2000) and our Information Access Policy.

You asked for the following information:

"Under the Freedom of Information act please could I request a full list of all the contractors and sub-contractors with contact details that are or have been involved in the construction of the South Wales Metro project."

Having reviewed your questions, we are able to provide the following information:

Please find below a list of both our CVL contractors and sub-contractors. Please note that sub-contractors appointed to carry out work under the value of £10,000 have not been included here, due to the significant length of time required to obtain this information. As such, including this information would exceed the time and cost limit for processing a request of £600, on the basis that it takes 24 hours of staff time at a standard rate of £25 per hour. The calculation of this cost can include:

- a) determining whether the requested information is held
- b) determining whether the information is subject to an exemption
- c) locating and retrieving the information
- d) extracting the information

Public authorities can refuse a request based on their own estimations and there is no official requirement for public authorities to include a breakdown of estimated costs. More information can be found here.

The direct contact details of our contractors and sub-contractors are exempt from disclosure under Section 40 of the Freedom of Information Act (personal information). This exemption covers the personal data of third parties where complying with a request would breach the principles of UK GDPR. More information about this exemption can be found here. In this instance, disclosing the details of our named contacts within each business (including name, telephone number, and/or email address) would breach UK GDPR.
